ALL BID PROPOSALS MUST BE ACCOMPANIED BY A BID BOND OR BANK CASHIER'S CHECK PAYABLE TO THE OSWEGOLAND PARK DISTRICT FOR TEN PERCENT (10%) OF THE AMOUNT OF THE BID AS PROVIDED IN THE INSTRUCTIONS TO BIDDERS. NO PROPOSALS OR BIDS WILL BE CONSIDERED UNLESS ACCOMPANIED BY SUCH BOND OR CHECK.

FAILURE TO MAKE SUCH A DISCLOSURE WILL NOT RESULT IN ACCRUAL OF ANY RIGHT, CLAIM OR CAUSE OF ACTION BY ANY BIDDER AGAINST THE OSWEGOLAND PARK DISTRICT.
