billing & payments

At time of registration, all payments will be set up via auto charge. Auto-Charge will process 14 days prior to the start of the session. Please see table below for payment due dates. Payment options include Debit or Credit Card Funds drafted from a Visa, Mastercard, American Express or Discover card. EFT (Electronic Funds Transfer) Funds are drafted directly from your bank account.

NON-SUFFICIENT FUNDS/LATE FEES

If you cannot make a payment on time, you can avoid the \$25 late fee by contacting the Park District's billing department prior to the scheduled due date. You will be asked to make an alternate payment plan, and if that plan is honored, the late fee will not be charged. When a scheduled payment has not been received by the date it is due, and you have not contacted the billing department to make an alternate payment plan, your child's attendance at Camp Connection may be disrupted.

Non-Sufficient Funds and payments received after the due date will incur a \$25 late fee

Oswegoland Park District is a member of the Fox Valley Special Recreation Association (FVSRA). FVSRA provides recreational opportunities for children with mental, physical, or emotional disabilities. In partnership with FVSRA, our staff will make every effort to provide children with disabilities the accommodations they require to participate in our program. In many situations, FVSRA will provide a companion who will give one-on-one support to the person participating. It may take up to ten days to secure a companion. If you or your child requires special accommodations, you must call 630.554.1010 within 24 hours of completing your registration to submit your request.
